**BOARD HIGHLIGHTS**

- Found the Dakota Nursing Program Practical Nursing (PN) Degree in substantial compliance with ND Administrative Code 54-03.2: and granted full approval of the Practical Nursing Program until March 2019.
- Found Dakota Nursing Program Associate Degree Nursing (A.D.N.) in substantial compliance with ND Administrative Code 54-03.2: and granted full approval of the Practical Nursing Program until March 2019.
- Reaffirmed the policy (Board Manual, Section 11, Continuing Education: Continuing Education Renewal Requirements RN or LPN license) and not accept renewal of certifications as CE for license renewal.
- Approved the application for Surgical Technician for Gerardo Javier.
- Directed staff to remind nurses that according to NDCC Clinical Laboratory Personnel 43-48-03 exemptions-2. Nurses duly and currently licensed to practice nursing and practicing within the scope of nursing license means that nurses may perform certain laboratory tests but nurses cannot delegate laboratory tests to UAP's.
- Adopted the proposed revisions to the Guidelines for Violations/Recommended Disciplinary Action based on revisions to title 54 NDAC.
- Adopted the new policy for practice without a current license/registration.
- Accepted the proposed revisions to the Personnel Policies to be congruent with State OMB Human Resource policy manual and the board staff development and expense fund policy.
