- 1) Investigative Case Presentations: NDBON deliberated on three Investigative Case Presentations. SAAG
 Bergeson and Hanson presented the CAC Stipulation on behalf of the CAC, including review of redacted patient medical records. Leo Wilking, legal counsel for each of the respondents and each respondent presented in support of a letter of concern, including review of redacted medical records.
 - a) Susan Buchholz, RN: Vetter motioned to accept the CAC Stipulation for Susan Buchholz, RN and enter its order to: Issue a Reprimand; assess \$700 penalty fee; assess costs and disbursements; and impose other terms as set out in the CAC Stipulation. The intent of this Motion is to reject the Susan Buchholz LOC which would impose a Letter of Concern, and to have that Letter of Concern shredded, and of no effect, as agreed by Ms. Buchholz in the Agreement to Resolve Disciplinary Action with Case Presentation to the Board. 4) Next Steps: ND Medi-Spas/Aesthetic Practices: SAAG Simonson and Pfenning provided an update on Medi-Spas/aesthetic practices in ND and the continued public concerns being brought to the NDBON via letters, emails, and formal complaints. Vetter motioned to direct the NDBON SAAGs and Directors to: 1) Pursue discussion with the North Dakota Attorney General's Consumer Protection and Antitrust Division or other applicable state parties to evaluate the potential need for oversight of Medi-Spas and aesthetic practices in North Dakota; and 2) Include a dedicated agenda item at the October Regular Board Meeting to provide a public forum addressing Medi-Spas and aesthetic practices; and include a summary of public comments received by the NDBON on the draft practice guidance on aesthetic practices.
