- a. APRN Licensure Compact (no action).** The National Council of State Boards of Nursing announced the rescinding and revising of the current APRN Licensure Compact. The rationale emphasized continued urgency for an APRN compact, noting that the existing compact has only four states enacted, while seven are required for implementation. The planned revisions will focus exclusively on licensure requirements, and remove provisions related to scope of practice. NDBON enacted the compact in 2021 and will need to pursue repeal of the legislation.
