## Overview and Methodology

The North Dakota Board of Nursing (NDBON) requires each approved prelicensure nursing education program to submit a comprehensive annual report. Data for the fiscal year (FY) 2021-2022 report was collected by the NDBON in collaboration with the National Council of State Boards of Nursing (NCSBN) in fulfillment of continuing compliance monitoring for ongoing approval of North Dakota nursing education programs in accordance with NDAC 54-03.2-07-09. The report provides a descriptive analysis of all data collected. Aggregate data collected from each NDBON approved nursing education program for this report is from the time period established in NDAC between July 1, 2021, and June 30, 2022.

All annual nursing education program data submitted is reviewed and evaluated for compliance with *NDAC Article 54-03.2 Standards for Nursing Education Programs*. Required data submitted by program nurse administrators for the comprehensive annual nursing education report aligns with U.S. Department of Education requirements for ND Board of Nursing recognition as a nationally accredited agency for approval of nurse education in North Dakota.

According to *NDAC Section 54-03.2-07-09 (2a.)* ND Board of Nursing approved nursing education programs are reevaluated at a minimum of every five years to ensure compliance with the standards for nursing education. A program that holds national nursing accreditation may seek the Board's approval through a paper survey process if the program received full approval following an onsite survey of no more than five years prior, if quality indicators remain constant as evidenced by the information provided in the NDBON Annual Nursing Education Report submission, and NCLEX pass rate for first-time test takers has remained above 80% in three of the last four years. If a program does not hold national nursing accreditation, an onsite survey is required every five years. Survey information and Board related actions are described in this section of the report.

Statistical data detailed in this report includes current and historical data about students, education program capacity, curriculum, graduates, National Council Licensure Examination (NCLEX®) results, and faculty for each nursing education program. Data and information included for each approved program includes 1) progress toward achievement of stated program objectives 2) qualifications and major responsibilities of the nurse administrator and each faculty member 3) current enrollment by class and student-teacher ratios 4) number of admissions per year for the past five years 6) number of graduates per year for past five years 7) curriculum plan 8) descriptions of resources and facilities, clinical areas and contractual arrangements.

Each program provides comprehensive information regarding practice facilities utilized for clinical practice experiences. Collectively programs in North Dakota utilize over 250 different practice facilities to complete student clinical practice experience requirements. Performance of students on state board examinations is monitored by the NDBON quarterly through NCLEX® reports provided by NCSBN and Pearson VUE reports. The past year and ten-year trend NCLEX® statistics are included in the report. The report also includes quarterly data submitted by programs utilizing *NDAC 54-03.2-04-08.1 Faculty Developmental Program* during the fiscal year. The Faculty Developmental Program rules allow programs with Board approval to utilize baccalaureate prepared faculty who are continuously enrolled and progressing in a graduate nursing education program. Programs may have up to fifteen percent of faculty full-time equivalents or one faculty full-time equivalent for a program with seven or fewer faculty who are academically unqualified per NDAC.

Each nursing education program is required to submit a current academic year course catalog. This report includes information throughout that verifies the collection of a current academic year course catalog from each of the nursing education programs. Information verified using the course catalog and referred to within the report includes but is not limited to national nursing accreditation, student and

academic policies, clinical policies including immunization, background check policies, courses, library resources and admission, progression and graduation policies and curriculum design.

A student handbook or program brochure that includes student policies for selection, progression (promotion) and graduation was provided with each program's annual report data and policies and procedures were reviewed and verified. Each program also provided an explanation of the way the program safeguards student health and safety within their report submission and procedures for the safety and wellbeing of enrolled students were reviewed and verified. Finally, each program submitted yearly fiscal budget information that was reviewed for comparison with the most recent annual and survey reports and programmatic change requests as applicable.

A narrative summary is provided for each of the approved nursing education programs which includes budgetary details submitted by the program and program related Board actions for the fiscal year including major programmatic changes and notifications, innovative nursing projects, program surveys and/or compliance reports.

## **United States Department of Education Grants North Dakota Board of Nursing Continued Recognition as State Approval Agency for Nurse Education**

The NDBON was first recognized by the DOE as an approval agency for nurse education in the State of North Dakota in 2002 for a period of two years and has been continuously recognized nationally since that time. The most recent review of the agency for renewal of its recognition occurred between January 2020 to September 2021. DOE staff virtually observed NDBON survey staff during several nursing program surveys during the review period as part of the recognition renewal review process. The NDBON is one of only five Boards of Nursing in the U.S. that are recognized by the DOE as specialized accrediting agencies.

The United States Department of Education (DOE) Deputy Under Secretary, Jordan Matsudaira, notified the North Dakota Board of Nursing (NDBON) on May 20, 2022, of his decision to approve the agency's request for renewal of recognition.

The National Advisory Committee on Institutional Quality and Integrity (NACIQI) met on February 23, 2022, to consider the DOE staff analysis report and recommendation related to the NDBON petition for continued recognition. NACIQI unanimously recommended approving the NDBON request for renewal of recognition at the meeting. Mr. Matsudaira concurred with the recommendations of DOE staff and NACIQI and granted the NDBON continued recognition as a statewide programmatic accreditor of nurse education programs in North Dakota for a period of four years.

The North Dakota Board of Nursing is legally authorized to regulate nurse education programs in the state of North Dakota under the Nurse Practices Act, NDCC and NDAC. The NDBON presently approves three graduate level nursing education programs, seven baccalaureate programs and five associate degree programs designed to prepare individuals for registered nurse licensure. In addition, the NDBON approves three associate degree programs and four certificate programs for practical nursing. Recognition by the DOE enables professional nurse education programs to seek eligibility for federal assistance pursuant to the Nurse Training Act of 1964, as amended. Recognition by the DOE ensures quality, accountability, and improvement of survey processes for the NDBON and provides reassurance to North Dakota citizens about the quality of nursing education programs in the state.

The DOE provides oversight of the postsecondary accreditation system through its review of all federally recognized accrediting agencies. The DOE holds accrediting agencies accountable by ensuring that they enforce their accreditation standards effectively. Also, as a part of the DOE's oversight roles, the Secretary of Education is required by law to publish a list of nationally recognized accrediting agencies that the Secretary determines to be reliable authorities as to the quality of education or training provided by the institutions of higher education and the higher education programs they accredit. The U.S. Secretary of Education also recognizes State agencies for the approval of public postsecondary vocational education and nurse education.

## Practical Nurse Education Programs

### Education Curriculum

Credit hours required for graduation from NDBON approved certificate practical nurse (PN) programs had a range of between 42-43 semester credit hours. The required course credit hours are shown in the tables below. Most clinical practice experiences for PN programs took place in the clinical practice environment and ranged between 49%-58% of the total clinical practice hours required for degree completion. The use of simulation technology as an adjunct to clinical practice experiences ranged between 7%-15% of total clinical practice hours required for degree completion, while skills lab practice experiences ranged between 31%-36% of total clinical practice hours required.

Credit hours required for graduation from NDBON approved associate degree practical nurse (PN) programs had a range of between 66-70 semester credit hours. The required course credit hours are shown in the tables below. Most clinical practice experiences for PN programs took place in the clinical practice environment and ranged between 47%-85% of the total clinical practice hours required for degree completion. The use of simulation technology as an adjunct to clinical practice experiences ranged between 5%-20% of total clinical practice hours required for degree completion, while skills lab practice experiences ranged between 8%-32% of total clinical practice hours required.





The majority of practical nurse students in FY 2021-2022 were reported for the first time as being in the age range of 25-30 years old unlike previous years with the average being reported as age 24 and below. Student age has been gradually increasing within practical nurse programs over the past ten years.


Prior annual education reports have not reported student racial composition and used only the category of “Minority” to differentiate from White students. Consistent with other years, most practical nurse students were reported as White, 68.6%. This percentage is lower than expected and most likely impacted by the high percentage of those reported in the other or unknown category and those not reporting their race. Programs in ND continue to be challenged with increasing racial diversity of students enrolled.





**Graduate Percentage by Certificate Practical Nurse Program**




**Ten Year Graduate Trend for Certificate Practical Nurse Programs**





**Graduate Percentage by Associate Degree Practical Nurse Program**




**Ten Year Graduate Trend for Associate Degree Practical Nurse Programs**



### Practical Nurse Program Faculty

Full-time equivalent (FTE) faculty are expected to work at least 37.5 hours per week and to teach, participate in curriculum development, hold office hours for student advisement, attend faculty meetings, participate in campus-wide events, attend professional development events, take part in scholarly activities and other responsibilities as defined by institutional policy. Part-time faculty work less than 37.5 hours per week and are responsible for assuming teaching responsibilities, usually collaborating with full-time faculty. Clinical adjunct faculty are responsible for teaching in the clinical practice environment under the direction of full-time and part-time faculty.













**Ten Year Graduate Trend for Associate Degree Registered Nurse Programs**



**Graduate Percentage by Baccalaureate Degree Registered Nurse Program**




**Ten Year Graduate Trend for Baccalaureate Degree Registered Nurse Programs**



## Registered Nurse Program Faculty

As with previous reports, respondents were asked to provide the number of full-time, part-time, and clinical adjunct faculty employed by the program. Full-time equivalent (FTE) faculty are expected to work at least 37.5 hours per week and to teach, participate in curriculum development, hold office hours for student advisement, attend faculty meetings, participate in campus-wide events, attend professional development events, take part in scholarly activities and other responsibilities as defined by institutional policy. Part-time faculty work less than 37.5 hours per week and are responsible for assuming teaching responsibilities, usually collaborating with full-time faculty. Clinical adjunct faculty are responsible for teaching in the clinical practice environment under the direction of full-time and part-time faculty.

## Highest Academic Achievement of Faculty







### Ten Year Student Enrollment Trend for APRN Programs





#### **Major Programmatic Change Requests and Notifications in compliance with NDAC 54-03.2-06-02:**

- July 2021 the Board approved the Dakota Nursing Program Consortium, Dakota College at Bottineau, Certificate Practical Nurse Program request to add a program satellite site in Jamestown, ND beginning fall 2022.
- January 2022 the Board reviewed a notification from the Dakota Nursing Program Consortium, Lake Region State College, ADN and PN Programs, regarding a change in delivery format for part of the program (didactic non-clinical courses) for the Devils Lake, ND campus.

#### **Program Survey/Compliance Reports:**

The most recent ND Board of Nursing program survey was an onsite survey conducted in April 2019, with the Board granting continued full program approval through April 2024. The next program survey is scheduled to be on-site in spring 2024. See Innovative Educational Model update below addressing compliance with progress reports for Innovative Model approved Apprenticeship Programs.

**Budget Overview:** The Certificate Practical Nurse and Associate of Science Registered Nurse Program budgets for each of the partner institutions are combined for this report.

- BSC-Overall Total PN & ADN: \$728,751. Salary \$643,230. Operations \$85,521. No capital expenditure reported.
- DCB-Overall Total PN & ADN: \$1,279,171. Salary \$854,533. Operations \$424,638. No capital expenditure reported.
- LRSC-Overall Total PN & ADN: \$1,230,228. Salary \$1,113,399. Operations \$116,828. No capital expenditure reported.
- WSC-Overall Total PN & ADN: \$772,424. Salary \$673,575. Operations \$98,849. No capital expenditure reported.

#### **Innovative Educational Model/Approach:**

January 2021 the Board approved the Dakota Nursing Program Consortium partner, Lake Region State College (LRSC) application for an Innovative Educational Model/Approach of a Nurse Apprenticeship Program for the Practical Nursing Certificate and Associate of Applied Science in Nursing Programs through January 2022. Implementation of the PN Nurse Apprenticeship Program was proposed to begin fall 2021 and the RN Apprenticeship Program to begin fall 2022.

Initial approval of the Innovative Model required the program's nurse administrator to submit a progress report bi-annually for continued approval of the Model. The reports were required to provide evidence that desired outcomes are being met, and public protection was not compromised. Progress reports were required to conform to the criteria set forth in the evaluation plan for the Nurse Apprenticeship Program.

Progress reports were submitted to the NDBON as required July 1, 2021, and January 1, 2022. The July 2021 progress report provided details of the marketing phase, partner agreements, and orientation plans and documents. The January 2022 progress report noted one student entered the PN program fall 2021 and had been working as a nurse apprentice in New Rockford, ND at an affiliated agency. Twice monthly meetings were occurring between the Apprenticeship Program Coordinator (APC) and the student and mentor separately. In addition, the student was meeting monthly with nursing faculty. Spring 2022 the student would be eligible to perform fall 2021 competency tested nursing skills. Apprenticeship program expansion plans were described including efforts to contract with additional healthcare facilities.

The NDBON found the progress updates met the reporting requirements and in January 2022 granted continued approval of the Model through January 2023, with biannual reports due in July 2022 and January 2023. The biannual program progress reports provided information about ongoing implementation efforts and did not indicate that students were adversely impacted by the innovation. Therefore, the program has not been required to provide documentation of corrective measures undertaken and their effectiveness.

#### **Comments:**

The Dakota Nursing Program Consortium consists of four partner institutions, Bismarck State College, Williston State College, Dakota College at Bottineau, and Lake Region State College, each which offer the certificate practical nurse and associate degree registered nurse programs at their institution. In addition to the programs being available at each of the partner institutions, Dakota Nursing Program Consortium offers the programs via satellite sites in many rural communities throughout North Dakota. The Certificate Practical Nurse Program has satellite sites in Ashley, Hazen, Harvey, Hettinger, Jamestown, Valley City, Minot, Mayville, Grand Forks, Tioga, Garrison, and Watford City. The Associate Degree Registered Nurse Program has satellite sites in Harvey, Valley City, Minot, Mayville, Grand Forks, and Garrison. During this FY Dakota Nursing Program Consortium associate degree registered nurse program added an additional program satellite site in Ashley.

### **Dickinson State University**

#### **Major Programmatic Change Requests and Notifications in compliance with NDAC 54-03.2-06-02:**

- July 2021 the Board reviewed the notification from Dickinson State University, AASPN and BSN Programs, regarding a change in program administration, newly appointed nurse administrator, Lucy Meyer, MSN, RN, effective July 1, 2021.

**Program Survey/Compliance Reports:** The ND Board of Nursing conducted an onsite/virtual survey of the programs in June, September, and October 2021 for consideration of continued full approval. The

Board granted continued full program approval through January 2027 and required a paper/interim survey of the programs in October 2026.

- January 2022 the nurse administrator submitted an the action plan and progress report as required related to the programs NCLEX-RN pass rate below the required 80% minimum standard

for two consecutive years. The progress report described continued consistent efforts to connect with faculty and program coordinators and provide mentoring. ATI policies and procedures continue to be followed. ATI and Kaplan reviews are planned in-person in May. NCLEX second quarter (October-December 2021) report not yet available to review current pass rate. The NDBON found the progress report met reporting requirements and required progress reports as previously determined March and July 2022.

**Compliance Issues with NDAC54-03.2:**

October 2021 the Board was made aware of the NDSCS AD RN Programs FY 2020-2021 NCLEX pass rate of 69.05%. The programs NCLEX pass rate for FY 2019-2020 was 75%, making that the second consecutive year that NCLEX pass rates were below the required 80% minimum standard.

Violation of **NDAC 54-03.2-07-01.1 Performance of Graduates on Licensing Examination** requires a program to submit a plan to the Board identifying possible contributing factors that affected the pass rates and how the identified deficiencies will be corrected. The nurse administrator, Ms. Deb Smith, submitted a detailed report.

Contributing factors identified by Board staff and nurse administrator include:

- New Leadership for the programs beginning January 2020 due to retirement. Mentoring providing during transition from former to current nurse administrator. Succession planning was supported by institutional leadership.
- New coordinator for the associate degree RN programs beginning fall 2021. Issues identified with previous coordinator through the programs' systematic evaluation process.
- One faculty member was dismissed, and another hired for associate degree RN programs beginning fall 2021. Issues identified with a faculty member through the programs' systematic evaluation process.
- COVID-19 pandemic forced nursing courses to move to online format unexpectedly within weeks of new leader assuming role. Classes moved back to in-person learning fall 2020.

The NDBON found the program in partial compliance with NDAC 54-03.2. Standards for Nursing Education Programs; and accepted the Programs' plan addressing the deficiency of non-compliance with NDAC 54-03.2-07-01. The NDBON required the Programs' Nurse Administrator to submit progress reports addressing the deficiency of non-compliance to the Board January 4, 2022, March 29, 2022, and July 5, 2022, and moved to continue full approval of the program.

#### Program Progress/Compliance Reports:

- July 2021 the NDBON found the progress report submitted by the Concordia College Baccalaureate Degree Nursing Program nurse administrator met the NDBON reporting requirements and provided evidence of substantial efforts made toward program compliance with 54-03.2-04-04. Baccalaureate or master's degree nurse education program faculty qualifications and 54-03.2-04-08. Employment of academically unqualified faculty and required the nurse administrator to submit a progress report providing evidence of program compliance by July 1, 2022.
- After completion of the onsite program survey fall 2019, the NDBON transitioned the College from the in-state approval process to annual recognition beginning FY 2020-2021 for student clinical practice placements in North Dakota healthcare facilities. At the time of the survey the program was found to be noncompliant with NDAC 54-03.2-04-04. Baccalaureate or master's degree nurse education program faculty qualifications and 54-03.2-04-08. Employment of academically unqualified faculty. Due to continued faculty shortage challenges, the NDBON has allowed the College to continue to use academically unqualified clinical faculty while monitoring progress toward compliance with NDAC.
- The report provided by the program detailed extensive efforts by the College and Program administrators to acquire adequate faculty including hiring one full-time qualified and five adjunct unqualified faculty member's last fall. Challenges included a year-long sabbatical for qualified faculty and the retirement of two full-time faculty members this spring. Summer courses were covered by all qualified faculty and in June. Staffing needs remain for two full-time faculty and a simulation coordinator which would be hired to begin by January 2022.

## **Minnesota State University Moorhead, MN**

**Program offered:** Traditional Bachelor of Science in Nursing (BSN) located in Moorhead, MN.

- July 2021 the Board approved the request from the Minnesota State University Moorhead, MN, Minnesota Alliance for Nursing Education (MANE) BSN Program allowing the use of a baccalaureate-prepared registered nurse enrolled and making progress in a master's program for clinical practice instruction Fall 2021 semester if needed.
- The Minnesota State University Moorhead, MN, MANE, BSN Program Nurse Administrator sought approval to use a baccalaureate-prepared nurse enrolled in a graduate program as clinical instructor for throughout 2020- 2021. The BSN program was started in fall 2020, and due to the pandemic and faculty shortages challenges continue to secure sufficient academically qualified faculty for clinical instruction. The program's clinical sites are primarily located in the Fargo ND community, thus requiring the program to meet NDBON Recognition requirements that clinical faculty be prepared at the master's level while providing oversight of students while in ND healthcare facilities. The program provides nursing education for many ND residents due to the institution's proximity to the ND border.
